## **Highway Report**

Scott DeNinno had a written report for the board members.

A second round of cold patching was completed.

The employees are working on culvert replacements and prep work for paving this year.

Truck 16 (Kenworth) just returned from the welding shop where the pintle chain floor and sand grate railed were replaced and it also had numerous rot holes and cracks repaired. Once painting is complete, the truck will be ready for summer work.

Truck 7 (2021 International) has been taken back to T & T for required repairs from the accident this winter and is expected to return in a week.

Truck 2 (2021 International) has been taken to HL Gage International for a warranty fan control repair and a recall.

Work was completed on construction of new sand grates for truck 16. These grates were manufactured in house at a considerable savings over purchasing them from Henderson equipment.

The millings pile across the street is scheduled to be crushed starting 5/24/23. The crushed millings will then be moved to another location. They will be utilized in mixing of cold mix pavement for completion of the scheduled work for this year. The equipment stored across the road will also be moved as requested by the Town Council.

The employees will be completing the first mowing of cemeteries in advance of the Memorial Day holiday.

Robert Pierce made a motion to accept the Highway report and Kathleen Montana seconded and Nicholas Vasil and Supervisor Breh were in favor.

## **Dog Control Officer**

Supervisor Breh said that Karen Jaquay is waiting for a court date for the citation that she issued.

She said that a dog was running loose between Oppenheim and Stratford and she finally picked it up in Stratford, so the Town of Oppenheim will not be liable for any of the bills.
